



## Morton Act to have impact on criminal justice system in Ellis County

Governor Rick Perry signed the Michael Morton Act into law as a way to reduce wrongful convictions through greater transparency in the criminal justice system. The act, Senate Bill 1611, will go

into effect Jan. 1, 2014 and have a major influence in Ellis County and throughout Texas for how prosecutors share evidence with defense attorneys.

The act is a response to the case of Michael Morton, in which he was wrongfully convicted in 1986 of murder-

ing his wife. The Innocence Project in New York cleared Morton's name through DNA testing, and he was formally acquitted in 2011.

Ken Anderson, who served as the Williamson County District Attorney and prosecuted Morton, was accused of deliberately withholding

evidence from the defense. A key piece of evidence withheld was a record of Morton's son saying his father wasn't the "monster" that murdered his mother.

The law requires prosecutors to provide copies of exculpatory evidence, which

# 15-year-old to face adult murder charge

On June 24, after a two-and-a-half day hearing, Judge Gene Calvert, Ellis County Court at Law #2, ruled that 15-year-old Victoria Alejandra Velasquez Navarrete, of Irving, may be tried as an adult for the first degree felony of murder.

The Ellis County & District Attorney's Office petitioned the court to certify Navarrete as an adult after she was arrested along with five other individuals, all adults, for the murder of Henry Fabian Villatoro.

Villatoro's body was discovered in Ellis County on April 6, with what Ellis County Sheriff's Office investigators described as "several gunshot wounds to the cranium."

On June 19, the Ellis County Grand Jury indicted all of the five adults for murder. Those individuals are: Abel Armando Martinez (19, from Irving), Roberto Lopez-Martinez (19, from Irving), Rafael Perez Morales (19, from Irving), Inmer abed Palma Garcia (24, from Irving) and Fredy Abel Martinez Rodriguez (24, from Houston).

Now that she has been certified as an adult Navarrete's case will also be presented to the Grand Jury.

**McClure takes seat on council**

MIDLOTHIAN — The Midlothian City Council oversaw the swearing in of Council member Place 3 and fire personnel promotion ceremony to open its meeting Tuesday night.

Judge Kent Traylor administered the oath of office to Jimmie McClure while her husband, Jim McClure, held the Bible. Many well-wishers for McClure and Jason Kyle, who stepped down as Council member Place 3, attended the meeting and filled the council chambers. A short reception for the two, their families and friends was held prior to the meeting.

Midlothian Mayor Bill Houston presented Kyle with two stone bookends impressed with the city's

official logo. Houston shook Kyle's hand and thanked him for his thoughtful input and clear legal perspective as a council member, then each of the other council members took a moment to speak a few words, thanking Kyle for his service and time on the

board.

Midlothian Fire Department Chief David Schrodt presented 11 personnel, six firefighters who completed their probation period and five for promotion.

New firefighters added to the department include Eli Fincher, Michael

Barker III, Sam Villa, Caleb Bondurant, Lance Silas and Stefan Schloemp. Rising to the rank of pump engineer were Brandon Rogers and Brad Bryan. Schrodt also promoted Matt Goleman to the rank of lieutenant and Scott Smith to captain.

During discussion, Parks and Recreation Manager Billy King presented a proposal to add 56 new parking spaces to Hawkins Spring Park, with 26 spaces and a sidewalk extension to Mountain Peak Park.

Councilman T.J. Henley, who acts as the Park Advisory Boards representative to the council, said the addition of parking spaces to Hawkins Spring Park is unwarranted.

"Won't the pressure on the park reduce with the construction of the

may justify or excuse an accused defendant's actions or remove guilt, instead of just providing access to the defense.

Ellis County District and County Attorney Patrick Wilson said his office has always had an open file policy and that the new law will just be a burden for his office.

"For the most part the Michael Morton Act simply puts into law the open file practices that have been employed by my office, and most prosecutors' offices around the state, for many years. As prosecutors we have a legal and ethical obligation to seek justice, not convictions. We should be able to play with our cards face up, allowing the cases we prosecute to stand or fall on their own merit," Wilson said. "The law also mandates that copies of documents and other evidence be provided to the defense, instead of simply providing access. That mandate will require a substantial commitment of financial and labor resources. In my office we are expediting our efforts to move to a digital workflow, which I hope will minimize some of that cost."

From the other side of the courtroom, Waxahachie Municipal Judge Joseph Gallo, who also serves as a criminal defense attorney, shared his thoughts on the Michael Morton Act.

"(This) is the most important Texas legislation enacted in my legal career," Gallo said. "These improvements should be welcomed by all citizens who value a

fair Texas criminal justice system. Not only will this legislation help to prevent the wrongful convictions of Texas citizens falsely accused of a crime, it also makes our system more efficient. There is a reason why this legislation was supported unanimously by both Democrats and Republicans. It was long overdue and clearly the right thing to do."

Wilson expressed fears of the new law adding to the burden on the Ellis County criminal justice system.

"The requirement by both the state and the defense in every case to document and acknowledge the specific discovery provided will likely be a tedious and time-consuming task," he said. "How that will be executed in each of the more than 3,000 cases my office handles every year remains to be seen. Keep in mind that I have only eight prosecutors handling all of those cases."

President of the Ellis County Criminal Defense Lawyer's Association Julissa Martinez said the signing of the act was "a bold move for the state."

"I'm excited about it being passed and know that it can only improve our state's justice system. I believe it will help resolve cases a lot quicker and I am looking forward to it coming into full effect on Jan. 1, 2014," Martinez said. "Currently we do not receive offense reports, witness statements and documents from the D.A., so I'm surely excited about being able to review all of this information and advise our clients accordingly. Of course there will be practical aspects to work out as these changes come."

However the new law effects the Ellis County criminal justice system, Gov. Perry believes, as do the bill's authors, Senators Rodney Ellis (D-Houston) and Robert Duncan (R-Lubbock), that this legislation will help to reduce Texas' high ranking in wrongful convictions in the U.S.

Texas is among the highest of U.S. states in exonerations, with 126, according to the National Registry of Exonerations.

"Texas is a law-and-order state, and with that tradition comes a

responsibility to make our judicial process as transparent and open as possible," Perry said. "Senate Bill 1611 helps serve that cause, making our system fairer and helping prevent wrongful convictions and penalties harsher than what is warranted by the facts."

According to a release from Perry's office, the bill will allow Texas' criminal justice system to be more responsive to a case, even after it has been tried, by ensuring a more open discovery process. The bill's open file policy allows for broader discovery, and removes barriers for accessing any evidence, except for items that would affect the security of a victim or witness.

The Michael Morton Act builds upon the U.S. Supreme Court ruling in Brady v. Maryland, a 1963 case in which the prosecution withheld exculpatory evidence from the criminal defendant, violating his 14th Amendment right to due process.
